

## Fees and Funding

Fees are charged per hour that your child attends and not funded by EYEF as detailed below. A termly invoice will be emailed to you during the 3<sup>rd</sup> week of term. Fees can be paid by Bank transfer (preferred), cheque or cash and can be paid in monthly instalments if required. Please see our fees policy on our website for further details.

#### 2 year old funding

Some families are eligible to free childcare for their two-year-olds. If you receive an invitation in the post, your child may be entitled to 2-year-old funding – but you will need to check your eligibility. If you have not received an invitation but think you may be eligible, you can apply online by registering at <u>Devon County Councils Citizen Portal</u> or by calling 0345 155 1013

### Early Years Entitlement Funding – from 3 years

In the term following your child's third birthday, you will be eligible for 15 hours per week free childcare funded by Devon County Council. All children receive this. If you choose to use these hours at pre-school, we will arrange this for you so you don't need to do anything to receive this. Please note: Devon's term start dates used for funding are 1<sup>st</sup> September, 1<sup>st</sup> January and 1<sup>st</sup> April so they would need to turn 3 before those dates in order to be funded for that term.

#### **30 Hours Funding**

We can accept 30 hour funding codes which can be shared with other settings. We are currently open for 25 hours per week. You must make the **application** online the term **before** you wish to start receiving the funding and you **can apply** up to 16 weeks before your child turns three. It you **are** eligible, you'll receive an 11-digit code which you then take to your **childcare** provider along with your national insurance number and child's date of birth. **Please note you must renew your details every 3 months to keep your 30 hour funding.**
